Guidelines for Authors

Introduction

These guidelines for authors have been compiled to help you to write and submit your contribution. They are designed to make your job simpler and faster, to reduce possible corrections and thus save you time. Please take the time to read them carefully. Chapter Specifications

1) General Remarks

Scope of the encyclopedia. The Anthropocene is a conceptual tool at the crossroads of several disciplinary fields: (1) geology and stratigraphy, of course; (2) Earth system sciences; (3) but also all the different disciplinary fields of the humanities and social sciences, all of which are now proposing their conceptualisation of the Anthropocene. The proposed Encyclopedia of a pluriversal Anthropocene (i.e. multi-diverse) articulates the biogeophysical knowledge of the Anthropocene as well as the socio-political knowledge. It is understood that in the conception of the Anthropocene that structures this Encyclopedia of a pluriversal Anthropocene, we give primacy to the paradigm of rupture that gives meaning to current biogeophysical research on the Anthropocene (i.e. that tomorrow is not an extension of today, given the possibility of crossing a tipping point) and to the paradigm of pluriversality, referring to the cohabitation of worlds.

Contribution level. Our aim is to publish a work of tertiary literature, which provides summarized information derived from primary or secondary sources, not an original article. As such it contains digested knowledge in an easily accessible format. Please do not use this article as an opportunity to publish (exclusively) your own scientific work (primary literature). Rather, the current state of literature should be summarized including also possible review articles. As in any other scientific article, proper references are needed to the original articles or review articles. Content therefore consists of established information in a particular field.

The level of contributions should be such that a graduate student can benefit from a contribution which is not from his or her area of expertise. **Each contribution should stand on its own** without an assumption that a reader will be seeing any other portion of the work.

Language. Use complete sentences when writing your text. Contributions should not contain first-person language such as "we have", "our graph shows", "I found" or "you have" etc. Avoid colloquial language as well as unnecessary foreign terms. Names, terms, abbreviations, etc. should be spelled consistently throughout the whole text (including figures and tables). Explain all the acronyms and abbreviations you use in your contribution. We suggest that authors whose native tongue is not English ask an English-speaking co-worker for assistance. Any words or phrases in other languages should be transliterated to English and translated as necessary.

File format. You can send us your entry in Microsoft Word.

Length of text. Try to limit your manuscript to the requested length: 1,000 to 10,000 words in length

This range excludes figures and references and should follow the internal structure indicated below. Please feel free to add tables and figures.

2) Structure

In order to ensure a user-friendly, coherent and comprehensive appearance, and to guarantee a smooth publication process and a seamless transformation of your manuscript into the final layout and various electronic formats (e.g., HTML for online publication, ePub for e-book readers), please adhere to the following article structures and do clearly define and organize the elements of your contribution:

- Entry title
- **Authors:** Please include the name of all article authors in the correct order with their affiliations in the manuscript and mark who is to be the corresponding author.
- Synonyms (if possible synonymous terms associated with the title/subject of your entry)
- Introduction (to introduce the reader to the subject)



- Main Text (Please rename this heading and add your own subheadings)
- Conclusion
- Cross-References (to other related articles in the encyclopedia)
- References (should be restricted to a maximum of 20)
 Please do not modify this structure in order to ensure a user-friendly, coherent and comprehensive appearance, and to guarantee a smooth publication process and a seamless transformation of your manuscript into the final layout and various electronic formats (e.g., HTML for online publication, ePub for e-book readers). You are free, though, to add subheadings within the headings provided.

3) Preparation of the Manuscript

Authors and co-authors – affiliation – sequence – corresponding. For Encyclopedias, Springer prefers to have a small number of authors for each contribution. If you want to include a co-author, please inform Springer before submission.

Please include the name of all article authors in the correct order with their affiliations in the manuscript and mark who is to be the corresponding author. Authorship changes are not permitted after a chapter has been submitted.

Headings and heading levels. Please don't use more than 3 heading levels. Heading levels should be clearly identified and each level should be numbered or uniquely and consistently formatted.

Never skip a heading level. The only exceptions are run-in headings which can be used at any hierarchical level.

Layout. Do not worry about the final layout, as this will be performed by Springer during the typesetting and proofing stage. In order to *accentuate* special parts of the text please use *italic type*. You may use standard characters to indicate a numbered or unnumbered list but please do not use any other layout elements such as indentations, auto-formatted bullet points, additional spaces, tab stops, clipart, etc.

Figures. Please feel free to provide figures and tables in full color or black & white. Figures are welcome in any standard format (jpg, tif, ppt, eps ...). If possible, please provide the original figure in high resolution (300 dpi minimum) to be submitted as separate file. All figure files should be numbered as follows: "contribution title, fig1.tif", etc. Please insert the file name of the figure as well as an explanatory legend underneath the paragraph which refers to the figure (but do not insert the legend into the figure). All symbols/abbreviations used in figures should be defined in the legends. In case you are using figures from other sources, please provide the correct copyright information in the legend and refer to obtained permission.

Tables. Please use only the table function in Microsoft Word for the creation of tables. You will find this function in the tool bar under Table \rightarrow Insert \rightarrow Table. Tables are integrated into the text underneath the paragraph in which they are referred to. All tables should be numbered for each contribution (1, 2, 3 ...). Please provide a title and explanatory legend for each table. All the symbols/abbreviations used in tables should be defined in the legend.

Abbreviations. Abbreviations, other than those very commonly used, must be defined at first use. Also, please use the following abbreviations: Fig./Figs. for Figure/Figures, and Eq./Eqs. for Equation/Equations; the word 'table' is not abbreviated.

- **Special characters**. Do not use graphics or your equation editor to insert single characters in running text. Take characters from your standard fonts such as Symbol. Furthermore, try to use the same characters as symbols in graphics and in the text or legend.
- Equations/formulas. Supply LaTeX (and accompanying PDF). Alternatively, if you are writing in Word please use the Equation Editor for equations. Please use numbers for equations, e.g. (Eq. 13).



4) Reference Citations

Cited references in the text should be included in name/year.

5) Reference List

- Include a **reference list at the end of each article** so that readers of single articles of the eBook can make full use of the citations.
- Include all works that are cited in the article and that have been published (including on the Internet) or accepted for publication. Personal communications and unpublished works should only be mentioned in the text. Do not use footnotes as a substitute for a reference list.
- Entries in the list must be listed alphabetically.

The rules for alphabetization are:

- First, all works by the author alone, ordered chronologically by year of publication.
- Next, all works by the author with a coauthor, ordered alphabetically by coauthor.
- Finally, all works by the author with several coauthors, ordered chronologically by year of publication.

Tip

- For authors using EndNote software to create the reference list, Springer provides output styles that support the formatting of in-text citations and reference list.

- For authors using BiBTeX, the style files are included in <u>Springer's LaTeX package</u>.

Reference style. Please use **Springer Humantities style** in your reference list. "For examples, see the detailed information for the **Springer Humanities style** at the end of this document".

6) Permissions

- If excerpts from copyrighted works (including websites) such as illustrations, tables, animations, or text quotations are included in your manuscript, please obtain permission from the copyright holder (usually the original publisher) for both the print and online format.
- Some publishers such as Springer have entrusted the <u>Copyright Clearance Center</u> in the US to manage the copyright permission procedure on their behalf. Please contact RightsLink for further information. Alternatively, Springer can provide you with a template to use when requesting permissions.
- Please comply with the instructions stipulated in the permission(s) concerning acknowledgements or
 credit lines within your manuscript (e.g., reference to the copyright holder in captions) and keep the
 written confirmation of the permission in your possession with the copy of your manuscript.
- Please be aware that some publishers do not always grant right of reproduction for free due to different reasons. Springer will not be able to refund any costs that may have been incurred in receiving these permissions. As an alternative, material from other sources should be used.
